We are objecting to the proposed Nain/Greenock/Daveyston/Freeling mine going ahead.

We are lifelong friends of Andrew and Deb Verner and often stay at Nain with our two children. As we live near the city centre of Adelaide our children love visiting Nain and playing with the cats, dogs, pet sheep and pet birds as well as wandering the property enjoying Mother Nature. We are very concerned about this proposed mine as we are well aware of the long term sacrifices that they have made for their autistic son, Ryan. Selling half of their farm at Riverton to fund health programs, social programs etc. to assist the long term outcomes for Ryan, while being necessary has still been a tough decision to make as they are a farming family.

The move to Nain is part of this long term plan and this proposed mine if it goes ahead will force them to have to look elsewhere, which would come at a major emotional and financial cost to the entire Verner family.

Our children love hearing the noises, particularly those of the pet cockatoo, however if the mine goes ahead we believe that those natural and enjoyable sounds will be overrun by the noises of machinery and trucks. We enjoy being able to get away from the noise of the city however the constant presence of these trucks and noises will make it seem as though we never left, making our trips out there much less enjoyable. We have also witnessed how a quiet and peaceful place such as this benefits the Verners autistic son Ryan. He is able to play with our kids and enjoy himself in a peaceful and relaxed environment with no background noises and traffic.

Our children love being outside while visiting the Verners, particularly visiting the animals, playing and exploring in a clean and safe environment. As parents we would be less inclined to let them play outside for such long periods of time if there was the strong presence of dust in the air that comes with a nearby mine especially in strong wind. Damage to both eyes and respiratory systems is likely and we would hate to think that our children are being harmed while simply playing outside and having fun. It would greatly decrease the appeal of the area for us.

5. Social and Environmental Benefits

5.1 Social

We fail to see the social benefits of a mine in this area. The appeal of the area would greatly decrease for us and its current image of a quiet, peaceful and clean place which we can look forward to visiting will be greatly diminished. We believe that others will feel similarly and the number of visitors and people who enjoy going out to Nain for the views and area will decrease.

5.3 Environmental

We are very concerned about the environmental impact that this mine will have on the area, particularly that caused by dust and noise. It would be a great shame to see this beautiful area virtually destroyed by the presence of a loud, dirty and ugly mine. We enjoy visiting immensely and hope that our visits are not about to cease due to our friends having to move away in response to the mine going ahead.

We strongly object to the mine and hope to see its development ceased.
